### **IfJ news**

---

The regular Zoom meeting for IfJ members which began at the start of the pandemic continues, providing an opportunity to discuss current issues, experiences and to gain support during ongoing and evolving situation. -Notes on the meeting will be on the web site soon. The Update notes are divided in to: 'Remote process', Covid-19 transmission, children, Gov.UK, updates, other and resources.

### **Intermediary discussions**

The ongoing discussions regarding experience and new approaches to working remotely are very informative in exploring a variety of options. Advice was sought in which a VP with literacy difficulties, attending the FC would be required to access paper documents and that this would not be practical with the need to keep social distancing. The following options were suggested:

Use of "Caseline" – an electronic bundle system it requires two computers one viewed by the VP the other computer allows pages to be turned ( limitations if VP not a confident reader or unfamiliar with technology, may still be a challenge sitting 2 meters away, may take time to establish links))

Similarly, using two computers as described in practice in NZ. The VP views a computer which is connected via a vga. This method allows the intermediary to zoom in to parts of a document being discussed and can simultaneously be viewed by the VP. (cons. As above)

Take photographs of relevant parts of bundle, place relevant pages in protective plastic pockets.



**Masks** (intermediary discussion ) intermediaries have been discussing what type of masks are suitable , the difficulties of establishing how to choose the best sort and the potential impact on communication.

More courts opening up: HM Courts & Tribunals Service is reopening another 16 courts this week after they were assessed to be suitable to holding socially-distanced hearings. Lord Chancellor Robert Buckland QC said the latest development will give people confidence justice can continue to be done safely. Around 159 courts have remained open during the Covid-19 pandemic. A further nine opened in the last few weeks.
